CRITERIA FOR ENTRY and TUITION for PROGRAM:

- Children must be at least three years old on or before October 1, 2017 (***Birth Certificate AND Proof of residency required***)

Tuition: due by the 1st of each month.

- \$250 per month ½ day
- \$150 per month ½ day – Must meet Reduced lunch eligibility
- \$75 per month ½ day – Must meet Free lunch eligibility

******* Tuition-paying students are not eligible for Transportation**

Preschool students deemed eligible for Special Education Services by the district Child Study Team attend the program at no charge to the parent(s).

Registration: March 15th – Letters sent to all currently registered PreK (must be received before April 15th)
April 18th – June 15th Open Registration Begins
June 27th – Lottery for placements (if needed)
